Complaint Filed Against Dondero in Fifth Judicial District Court

POST Notifies Esmeralda County - Dondero Disqualified to Serve as Sheriff

The Fifth Judicial Court confirmed on Tuesday, October 31, 2023, that the Nevada Attorney General has filed a civil complaint against Nick Dondero, who is currently serving as the Esmeralda County Sheriff. The 22-page document details the allegations against Dondero including his inability to obtain POST certification, his misdemeanor domestic battery as it relates to being a peace officer in Nevada, along with troublesome actions committed by him unrelated to his conviction, and more.

According to court documents, Dondero must automatically vacate the office of Esmeralda County Sheriff by January 1, 2024, unless the court takes actions prior. *The Fallon Post* will provide more detailed information once we have fully reviewed the contents of the complaint.

Additionally, Nevada Commission on Peace Officers Standards and Train-

ing (POST) notified Dondero in August that he is disqualified from serving as a peace officer.

The Fallon Post has confirmed that Dondero is neither POST certified nor eligible for certification, as conveyed to him and the Esmeralda County commissioners, along with other county officials in a letter dated August 14, 2023. In the notice, POST Executive Director Michale Sherlock stated, "POST is giving notice to you that you are disqualified from serving as a peace officer. As such, you will not be eligible for certification as required by Nevada Revised Statute."

The notice explicitly states Dondero is ineligible to hold the office of Esmeralda County Sheriff due to the legal prohibition that prevents him from owning or possessing a firearm.

"Nevada Commission on Peace Officer Standards and Training (POST) wishes to inform you of your POST certification status as the elected Sheriff of Esmeralda County. As you

may know, the relevant portion of NRS 248.005 states: 3. If a person [has a documented history of physical violence], as described in paragraph (c) of subsection 1, is a candidate for the office of sheriff in a county whose population is less than 30,000, the person is not required to meet any requirements with respect to employment, service,

certification or training at the time he or she files his or her declaration of candidacy for the office."

Sherlock further explained: "In addition, during its 2023 session, the

I got one. I got a horse. I'm so excited I can't even write. Her name is Elvira. She is big and brown and very, very sweet. She lives at my dad's. I have to go over there every day now and feed her and pet her and love her.

We always had horses growing up and absolutely took them for granted. My sisters and I could never imagine a world where we didn't have horses. There were Ives, Emma, and Buddy and any number of beautiful, thoroughbred ranch horses, jumper prospects, and horses off the track that were learning to be polo ponies. We had our pick of whatever was in the corral.

I'm on the BLM Mustang, the Nevada Horses, all the sale barns, and the Aging Horsewomen International site. It's really educational and has been very tempting, but I've been good, and I'm waiting for the stars to align.

And then they did. Mostly, Elvira is three, and she's only halter broke. Do not think about the Aging Horsewoman thing here. She got scraped up at the place I got her, and apparently, she also got the flu, so now we're doctoring the brand-new horse and isolating her from all of Dad's horses. I'm not the most popular girl on Yeoman Lane for bringing the cooties to the barn, that's for sure.

But here we are – 54 years old- my dream came true.

So I'm heading to the store for horse medicine, and when I get back from doctoring Elvira, I'll be right here...

Nevada Legislature passed SB 225, which was signed into law by the governor. This law adds a provision that disqualifies anyone who has been convicted of a domestic violence offense, **whether or not that offense has been expunged or sealed**, to serve as a peace officer. POST is giving notice to you that both under the NAC and under the NRS, based on SB 225, you are disqualified from serving as a peace officer. As such, you will not be eligible for certification as required by Nevada Revised Statute."

This prohibition poses a significant challenge to fulfilling the duties of a sheriff. As Churchill County Sheriff Richard Hickox has explained, "Carrying a gun is a major tenant of being a law enforcement officer in Nevada." In simple terms, police officers in America are expected to carry firearms.

Up until this week, there has been no formal action taken to remove Dondero from office, either by the officials of Esmeralda County, the Bureau of Alcohol Tobacco & Firearm, or the Nevada Attorney General's Office, despite the firearms prohibition.

In addition to these disqualifications, Dondero, who initially campaigned on a platform of "holding people accountable," has taken legal action against those who have raised concerns about his eligibility. *The Fallon Post* reported on June 15 that the Esmeralda County District Attorney sent a cease-and-desist letter to a whistleblower, who had challenged the legality of Dondero's position as sheriff, which asserted, "Statements you have made that Sheriff Dondero cannot legally carry a weapon and that Sheriff Dondero cannot be POST certified. Those statements imply that

the Sheriff has been convicted of serious criminal acts, which is false. If you continue in defamatory statements, Sheriff Dondero intends to bring an action against you for general, special, and exemplary damages."

GoFundMe raises money for Dondero:

More than four months ago, before POST's letter to Dondero, a supporter of Dondero named Greg Rentchler, owner of Southwest Tactile gun sales in Dyer, NV, initiated a GoFundMe campaign to raise funds for Dondero's legal expenses as sheriff. To date, the campaign at www.gofundme.com/f/help-defend-our-well-deserved-sheriff has raised \$1,610 toward the \$100,000 goal.

According to Rentchler, Dondero "has been lambasted and defamed by former deputies, a Nevada newspaper, former sheriff, and others! I am initiating this GoFundMe fundraiser because Sheriff Dondero has been forced to hire legal representation in defense of his personal reputation and the reputation of his Office. You see, Nick campaigned on holding people accountable for their actions. The individuals defaming Nick are trying very hard to hurt his efforts with the State of Nevada, the Sheriff's and Chief's Association, and the State's Peace Officer's Standards and Training by perpetuating rumors that he is not qualified for the position that he was elected."

Dondero served as an officer with the City of Fallon Police Department in 2007 for approximately seven months.

NDOT Seeks Public Input on Proposed Expansion Projects

I-80 Improvements Considered Between Sparks and USA Parkway

Staff Report

The Nevada Department of Transportation (NDOT) will conduct a public information meeting, both in-person and virtually, to gather public input for the preliminary environmental review of the proposed expansion of Interstate 80 to the east of Sparks.

The public will have the opportunity to participate in-person and virtual meetings to learn more and offer insights into the potential improvements to the interstate.

The community can access project details and share their comments by visiting the virtual public meeting at I80EastNV.com from October 23 to November 22, 2023. Information will be available in both English and Spanish.

An open house public meeting will be held on Tuesday, November 7, between 4-7 p.m. at the Lockwood Com-

munity and Senior Center at 800 Peri Ranch Road. The meeting will follow an open house format, with a formal presentation beginning at 5:30 p.m.

In collaboration with the Federal Highway Administration, NDOT is seeking public input on the proposed expansion and enhancements of I-80 from Vista Boulevard to USA Parkway as part of the project's National Environmental Policy Act (NEPA) phase. These potential enhancements encompass widening I-80 between Vista Boulevard in Sparks and the State Route 439 (USA Parkway) interchange. The plan involves replacing certain existing interstate bridges,

expanding roadway shoulders, and implementing interchange improvements, among other enhancements, all aimed at enhancing traffic mobility and safety for the approximately 48,000 vehicles that traverse the interstate daily. The proposed widening will require extensive geotechnical engineering due to the steep slopes and rock formations adjacent to the interstate.

Traffic has increased 61 percent over the past ten years. In a recent five-

year period, an average of 155 crashes occurred every year on this section of interstate. Interstate widening and improvements are projected to cut total crash rates by approximately 25 percent, and fatal and injury crashes by approximately 30 percent, over a 25-year period.

Over recent years, NDOT has lengthened and improved I-80 USA Parkway and Lockwood ramps for safer, designated access to and from the interstate in the area.

U.S. 395 Southern Sierra Corridor Study

NDOT will host in-person and virtual meetings to review existing corridor conditions and gather public feedback on U.S. 395 between Carson City and the Nevada-California border at Topaz Lake.

In a recent five-year period, eleven lives were lost on this section of the highway. The study, projected to be completed in spring 2025, will develop goals, recommendations, and strategies to enhance roadway safety and use and provide decision-makers with guidance for potential corridor improvements in the future.

Visitors can view project information and provide comments by visiting the virtual public meeting at ndotus395.com anytime between October 23 and November 22, 2023.

There will be a meeting held on

Monday, November 6, between 4-7 p.m. at the Carson City Community Center Gym at 851 East Williams Street, with a second meeting on Wednesday, November 8, between 4-7 p.m. at the Douglas County Community and Senior Center at 1329 Waterloo Lane in Gardnerville.

The formal project presentation will be live-streamed on November 8 at 5:30 p.m. via the NDOT Facebook page (@NevadaDOT). Livestream participants will be allowed to provide comments and ask questions. Comments can be submitted at the public meeting or via instructions provided during the virtual public meeting.

Justice Court News

New River Township Justice Court convened on October 23 under the leadership of Judge Benjamin Trotter.

Herbert Crazyhorse Williams, in custody, appeared for arraignment on a misdemeanor charge of Battery on a Peace Officer, which carries a maximum sentence of 364 days in jail. According to the criminal complaint, on September 21, Williams allegedly "shoulder-checked" an officer from the Fallon Police Department near 2333 W. Williams Avenue. Additionally, he was accused of pushing the officer and grabbing his arm. Williams was also charged with Assault on an Officer, which is categorized as a gross misdemeanor.

In Nevada, Battery is defined as the deliberate, unlawful touching of another person, and Assault escalates to Battery when physical contact occurs. The allegations further stated that these actions took place while Williams was aiding in the commission of a crime. Specifically, he was accused of assisting another individual in leaving Walmart without paying for items and willfully delaying, resisting, or obstructing law enforcement from obtaining evidence of the crime. Judge Trotter scheduled a status hearing for November 2.

Dalton Kaady, in custody, pleaded not guilty after being arraigned on multiple charges. These charges included:

1. DUI under NRS 44C.110 occurred on October 21, near 2023 Coleman

- Road. The allegations mentioned that Kaady had a blood alcohol level of .08 and was under the influence of chemical substances. Additionally, this incident took place within a construction zone.
2. NRS 43.560 - Driving with a License that has been Canceled, Revoked, or Suspended.
3. Failure to comply with zone flags or signals under NRS 484B .330.
4. Failure to Maintain the Lane under NRS 484B.233/.130.

Kaady requested to be released on his Own Recognizance (OR). However, the District Attorney's Office objected, citing unrelated pending DUI charges as the reason for his revoked license. Despite this objection, Judge Trotter granted the OR per statutory guidelines, with the provision of Court Services Supervision and random drug and alcohol testing. A status hearing was scheduled for November 9, and Kaady was appointed representation by the Churchill County Public Defender's Office.


Raymond Gardner, in custody, appeared regarding a 19-year-old case after being arrested on a warrant for failing to pay ordered fines. Gardner explained that the fines were related to traffic violations he had not paid after serving in a California jail in 2008 or 2009. He was arrested in Mound House early on the morning of October 23 and transported to Churchill County due to the outstanding warrant. Court documents indicated that Gardner still owed \$1,948 in fines. He

expressed his belief that the fines had been resolved due to the passage of time.

Gardner informed the court that he was currently in rehab, working to make amends, and expressed his willingness to establish a payment plan to address his financial obligations.

The court ordered Gardner to make monthly payments of \$75, with the first payment due by November 15. Future status hearings will be conducted via Zoom, as Gardner now resides in Pinole, CA.

Key Developments in Central Nevada Health District Progress

The Central Nevada Health District Board of Directors held its regular meeting last week to discuss and approve several housekeeping matters as they continue activities to set up the Health District and get it properly functioning.

A partnership with Verizon Wireless was approved to obtain State Vendor pricing. Sub-agreements with the State of Nevada, Department of Public and Behavioral Health were authorized; one for \$32,998 to provide Chronic Disease Education, a second for \$55,860 to provide abstinence education for youth, another for \$84,189 for Substance Prevention, and lastly one for \$42,528 for Influenza Vaccination for children.

Board members also approved an agreement between the district and Partnership Douglas County to address tobacco prevention control for \$10,000.

The board approved the Fiscal

Year 24 1st quarter fiscal report provided by Administrator Daren Winkelman.

Community Health Officer Tedd McDonald, MD, submitted a written statement to the board reporting on the current health alerts, including an increased rate of measles cases for 2023 related to an increase in international travel, tick bite prevention, and seasonal migration of rodents into human living spaces. He also summarized symptoms of Long COVID through the Centers for Disease Control. Twelve symptoms are included in the diagnosis of long-term COVID, and the diagnosis is currently based on a history of COVID infection and persistent symptoms, including fatigue, brain fog, dizziness, and change in taste and smell. More information can be found on the CDC website.

He also reported that CNHD staff had passed testing for in-house dispensing in the pharmacy, and the district is now certified for those services.

Clinic services at the Churchill,

Mineral, and Pershing clinics are now underway, and the clinic staff will also be taking on complete tracking services of tuberculosis cases.

Outreach events are planned and continue to be centered on community health and return-to-school events across the district.

Winkelman also presented an administrative update: the district continues to implement program initiatives and participate in community events across the four-county area. CNHD staff shadowed the Division of Public and Behavioral Health staff during the Burning Man event and will work with organizers to ensure a smooth transition for next year. Community Clinics are beginning to see more patients for a variety of services.

He also said the hiring of team members is a critical focus for the district, and interviews continue to be conducted with exceptional support operations staff recruited so far. Recent interviews were held for an epidemiologist who will begin work

in late November. Sean Cridland has joined the team as an Environmental Health Specialist, Amber Lewis is a new Registered Nurse, and Krystal Babcock joined the team as support staff.

District member entities have so far funded the district with \$511,5176. Other funding includes \$333,333 from the Fund for Healthy Nevada and environmental health inspection permits of \$14,000.

The CNHD comprises the communities of Churchill County, the City of Fallon, Pershing County, Eureka County, and Mineral County. The board members are Chairman Ken Tedford, Vice Chair Cassie Hall, Larry Rackley, Denise Ferguson, Tyson McBride, Bob Erickson, Jeb Rowley, Rich McKay, Jim Barbee, Shannon Ernst, and Justin Heath. The board typically meets the second Thursday of each month at 1:30 p.m.

A Closer Look at Sheriff Nick Dondero's Controversial Tenure

In recent months, The Fallon Post has diligently reported on Nick Dondero, who, in January 2023, assumed the role of Esmeralda County's elected sheriff.

The Fallon Post reached out to the Fifth Judicial Court in Esmeralda County, who confirmed on Tuesday, October 31, 2023, that Nevada Attorney General has filed a civil complaint against Nick Dondero. The 22-page document, a matter of public record, extensively lists the allegations against Dondero in relation to inability to serve as a law enforcement position in Nevada, as well as an elected agent in the capacity. Further, the document extensively details his misdemeanor domestic battery as it relates to being a peace officer in Nevada, along with troublesome actions committed by him unrelated to his conviction, and more that include actions committed by him unrelated to his conviction, and more. According to the complaint, Dondero must automatically vacate the office of Esmeralda County Sheriff by January 1, 2024, unless the court acts prior. Through an extensive and ongoing investigation, we have unearthed specific indisputable facts that are cited in the civil complaint. These unequivocally disqualify him from serving as a law enforcement officer. For nearly a year, he has retained his position. However, that is about to change. If you have been following the progression of stories and editorials on Dondero, you will see why this is a matter of concern. Here, you will find much of the information written in the article on Page 3, "POST Notifies Esmeralda County Dondero Disqualified to Serve." However, as I have been continuing to research, obtain documents, and talk to sources about the situation in Esmeralda County, I find myself at odds with the fact someone with a domestic violence conviction remains as sheriff. In addition, Dondero, who initially

campaigned on a platform of "holding people accountable," has taken legal action against those who have raised concerns about his eligibility and have spoken out against his alleged breach of public trust. Notably, The Fallon Post reported that the Esmeralda County District Attorney sent a cease-and-desist letter to a whistleblower, challenging the legality of Dondero's position as sheriff.

More than four months ago, before POST's letter to Dondero, a supporter named Greg Rentchler, owner of Southwest Tactile gun sales in Dyer, NV, initiated a GoFundMe campaign to raise funds for Dondero's legal expenses as sheriff. Soliciting funds for a public official has caused concern, especially as:

1. No charges had been filed.
2. Dondero cannot be certified by POST.
3. He is ineligible to hold the office of sheriff.
4. Public trust has been breached.

Rentchler's motivation for the campaign was rooted in the belief that Dondero had been criticized unjustly.

According to Rentchler, Dondero "has been lambasted and defamed by former deputies, a Nevada newspaper, former Sheriff and others! I am initiating this GoFundMe fundraiser because Sheriff Dondero has been forced to hire legal representation in defense of his personal reputation and the reputation of his Office. You see, Nick campaigned on holding people accountable for their actions. The individuals defaming Nick are trying very hard to hurt his efforts with the State of Nevada, the Sheriff's and Chief's Association, and POST by perpetuating rumors that he is not qualified for the position that he was elected." This representation of Dondero infers that he is a victim and is being persecuted.

In response to the mounting challenges to his position, Dondero has sought legal representation. As a result, legal actions have been taken against those who have spoken out. On September 14, his attorney sent legal documents to individuals or entities to challenge their legal right to disclose certain information related to the facts that disqualify Dondero from holding office. While this may be a highly com-

plex legal matter, it is not a Constitutional one.

Consider that Fallon is a small town, even more so before 2007, when Dondero served as an officer with the City of Fallon Police Department for approximately seven months. In cases where a former law enforcement officer is involved in activities that appear to violate the law, place individuals at risk of violence, and compromise public safety, it does not go unnoticed. Nor is it forgotten. Court orders may restrict various entities from acknowledging the existence of specified legal documents, but they cannot silence the First Amendment rights of individuals with memories. Documents and photographs serve as invaluable sources of information, but the testimony of individuals carries significant weight and cannot be dismissed. Erasing the written record of an event does not erase its existence.

So why does all this matter? Some have asked, "Why do we care about what is happening in Esmeralda County – the least populated county in Nevada, home to less than 1,000 residents?" While it may seem inconsequential to many, Sheriff Hickox and other law enforcement officers disagree. "It sets a precedent," said Hickox, "What happens there affects us here – it affects us all."

In a recent update to the proceeding, the Chief Deputy for the Fifth Judicial Court in Esmeralda County acknowledges that a complaint has been filed against Sheriff Nick Dondero.

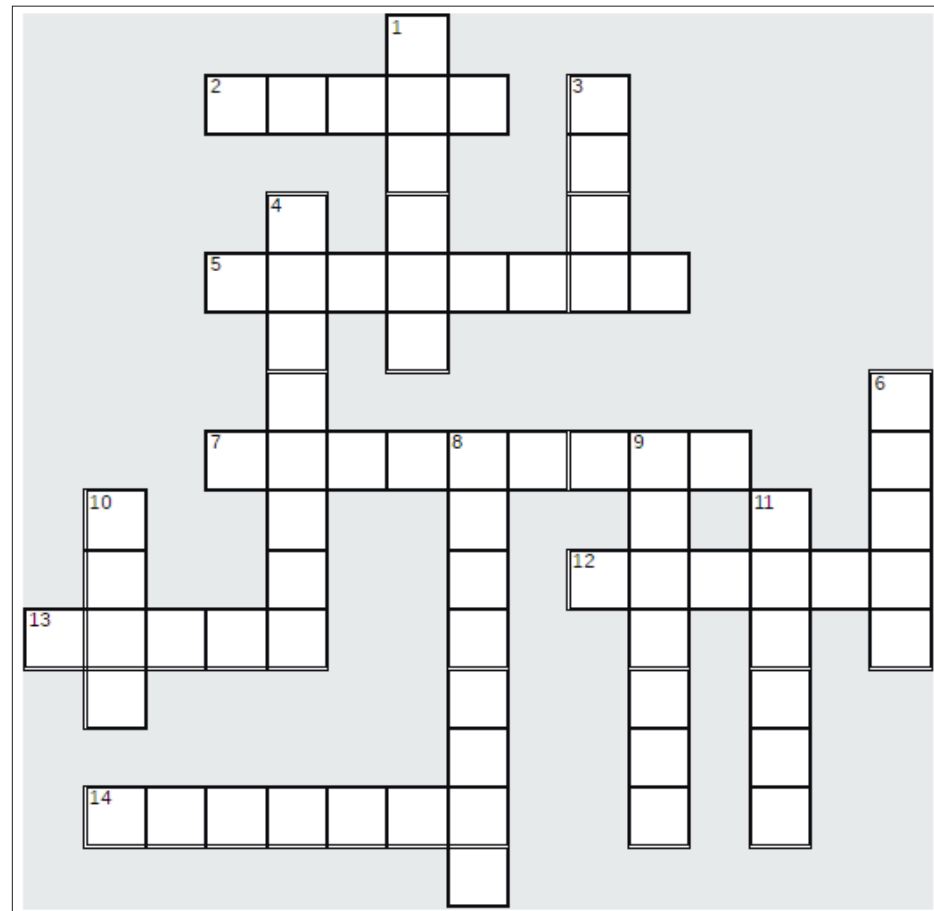

What's Cooking in Kelli's Kitchen - It's Stew Season

I am a daily shopper, which gets me out of menu planning and allows me to bump into people at the store. Sunday, I caught up with old friends and was so pleased to hear that each of them felt a connection to me through the threads of this article, and they had even cooked a number of the recipes. I am so grateful to hear from folks who enjoy this column, especially those who have tried cooking the recipes I share—that's the whole point of this little endeavor.

Here are two recipes for you: one that takes some time for the weekend and a quicker one for the week.

Weekend Dinner

Lamb and Squash Stew (Miyar Taushe)

Kelli's adaptation of a recipe from Yemisi Aribisala and Ligaya Mishan

INGREDIENTS:

1 pack of lamb shanks (1 ½ - 2 lbs)
Salt and Pepper
1 yellow onion, sliced
1 habanero chile
1 2" piece of fresh ginger, minced (or 6 cubes of frozen ginger)
6 garlic cloves, minced (or 6 cubes of frozen garlic)
3 dried bay leaves
1 qt chicken stock
2 Brulee squash (or 1 large butternut), halved lengthwise, seeds removed
3 T coconut oil, divided
¼ t nutmeg
1 T pumpkin seeds
1 14 oz can of Mutti cherry tomatoes
1 Anaheim pepper, stem and seeds removed
½ bunch curly kale, stem removed, roughly chopped

DIRECTIONS:

1. Heat oven to 350°. Season the lamb with salt and pepper and put in a large lidded pot with half of the onion, habanero chile, ginger, garlic, bay leaves, and 2 cups chicken stock. Bring to a boil. Cover and put in the oven for two hours.
2. Season the cut sides of the squash with salt and pepper, drizzle with 1 T coconut oil, and place cut side down on a lined sheet pan. Bake alongside the lamb until the skin collapses and the flesh is soft, around 1 hour. Set aside to cool.
3. When the lamb is tender, transfer it to a plate. Discard bay leaves. Pour the lamb stock into a blender and add the cherry tomatoes, Anaheim pepper, and remaining onion. Blend until smooth. Return to the pot.
4. Add 2 T of coconut oil to the lamb broth and simmer on medium-low for about 30 minutes.
5. Scrape the squash into the same blender and add ½ c of stock, nutmeg, and pumpkin seeds. Blend until soft and creamy, adding more stock as necessary. Add the squash puree to the simmering lamb stew. Turn the heat down to low. Remove the lamb meat from the bones, add to the pot along with the chopped kale, and let simmer for about 10 minutes. Season to taste with salt and pepper.

Week Night Dinner

Spiced Chickpea Stew

Recipe by Alison Roman adapted by Kelli

INGREDIENTS:

¼ c olive oil
6 garlic cloves, minced (or 6 cubes frozen garlic)
1 yellow onion, chopped
1 2" piece of ginger, peeled, minced (or 6 cubes frozen ginger)
Salt and black pepper
2 t turmeric
1 t red-pepper flake
2 15 oz cans of chickpeas, drained, rinsed
2 15 oz cans of full fat coconut milk
2 c chicken stock
½ bunch of curly kale, stem removed, roughly chopped
1 bunch mint for serving
Yogurt for serving

DIRECTIONS:

1. Heat ¼ c oil in a large pot over medium heat. Add garlic, onion, ginger, salt, and pepper. Cook until the onion starts to brown on the edges.
2. Add turmeric, red pepper flakes, and chickpeas. Season to taste with salt and pepper. Cook, stirring often, until the chickpeas sizzle and fry in the oil. When the chickpeas have broken down a bit, browned, and turned crisp, remove one cup for garnish.
3. Using a wooden spoon, crush the chickpeas slightly to release their starch. Add coconut milk and stock, season with salt and pepper.
4. Bring to a simmer, scraping up any bits that have formed on the bottom of the pot. Cook 30-35 minutes until thickened. Keep sim-

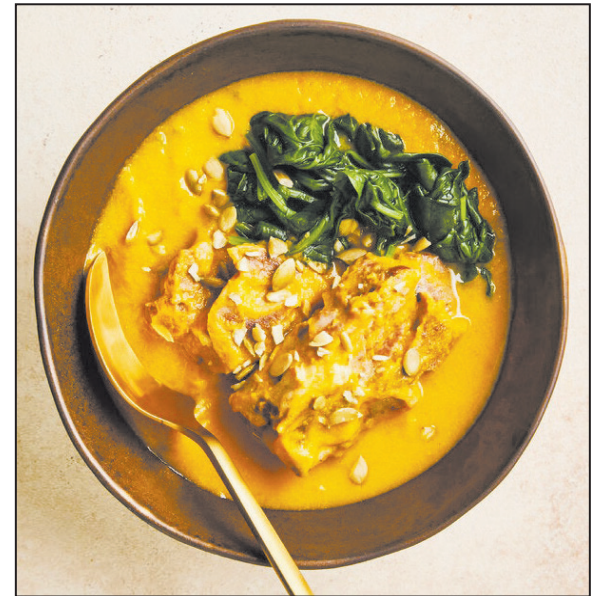

- mering, or add additional liquid to reach your desired consistency.
5. Add in the kale and cook until wilted and soft. Serve topped with mint, reserved chickpea garnish, and yogurt.

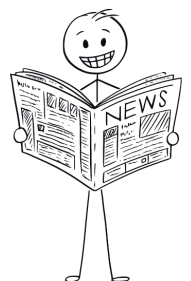


